## THE GOVERNOR'S PROPOSED BUDGET WOULD CUT PAYMENTS TO PLANS THAT ENROLL CHILDREN IN THE HEALTHY FAMILIES PROGRAM

The Healthy Families Program provides needed health care services to more than 800,000 California children. Governor Schwarzenegger proposes a 5 percent reduction in payments to health plans in the Healthy Families Program. This reduction would result in General Fund savings of \$22.4 million in 2008-09, but also would cause the state to lose \$40.7 million in federal funds.
