



# The Great Recession Has Not Ended for Many California Families




### California's Job Growth Has Flat-Lined Since Early 2011






The Number of People Looking for Work Nationwide Exceeds Available Jobs by More Than Four to One

### The Number of Long-Term Jobless Is Nearly Seven Times Higher Than It Was Before the Recession Began



Number of Individuals Receiving CalWORKs Cash Assistance in June 2011 = 1,475,623



After Declining for Many Years, the Number of CalWORKs Families Has Risen Substantially Due to the Great Recession




### Number of Families Receiving CalWORKs Cash Assistance Generally Declined Through Mid-2007



# The Purchasing Power of CalWORKs Cash Assistance Has Dropped Significantly




Purchasing Power of CalWORKs Grants Has Dropped by More Than Half Since 1989-90






■ Federal Poverty Line for a Family of Three


### The CalWORKs Grant Level Is Lower Than TANF Grants in 27 States, After Adjusting for Housing Costs






### Total Welfare Spending in California Dropped Substantially Between 1996-97 and 2010-11
