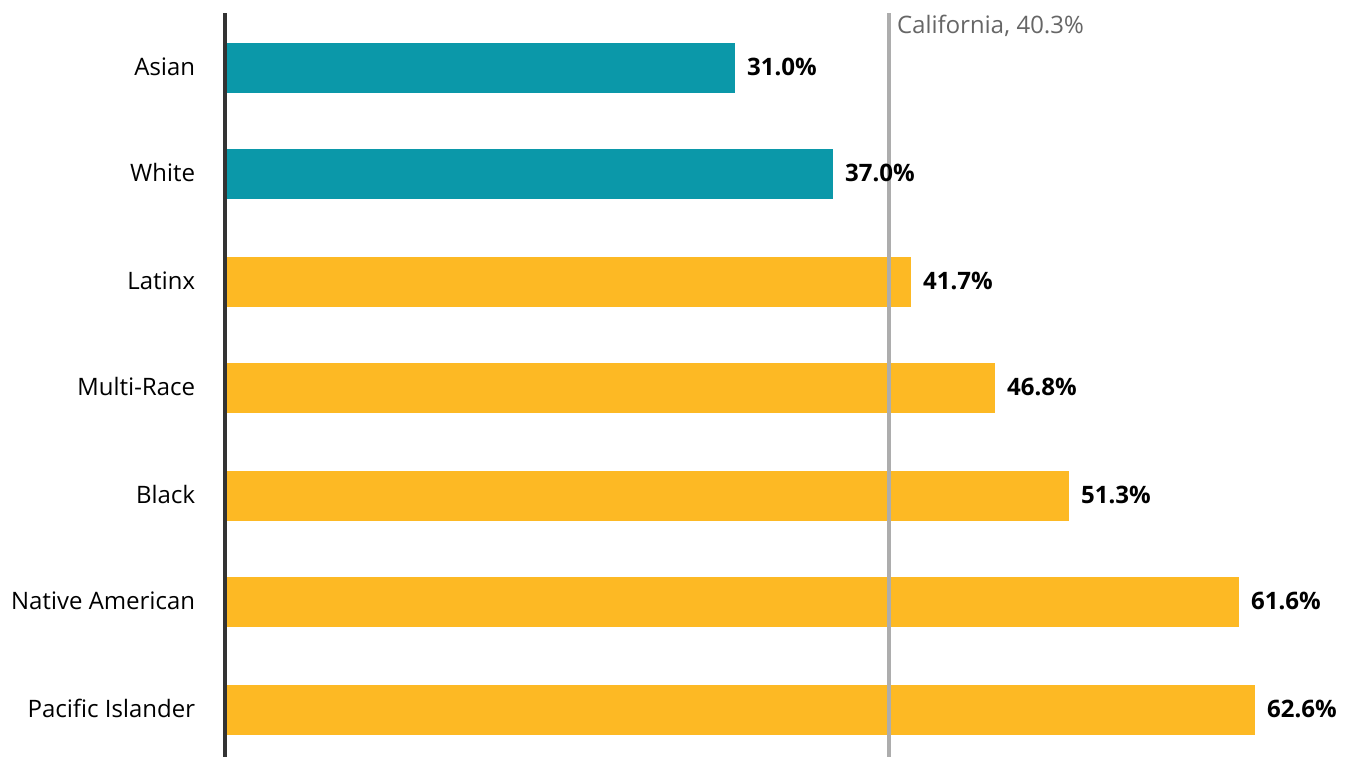




California Women's Well-Being Index Food Hardship Fact Sheet

The California Women's Well-Being Index provides a comprehensive, composite measure of how women are faring in each of the state's 58 counties. The Index encompasses five "dimensions" – Health, Personal Safety, Employment & Earnings, Economic Security, and Political Empowerment – each of which is made up of six indicators. This fact sheet shows statewide data by race and ethnicity for the Food Hardship Indicator, as well as the value and rank for all 58 counties.

Note: Data are for individuals age 18 and over. The California Health Interview Survey (CHIS) defines food insecurity as not being able to afford enough food and only asks this question of adults with incomes less than 200% of the federal poverty level. The ethnicity category ("Latinx") and the race categories are mutually exclusive. Individuals who identify as Latinx are included only in that category and are not reflected in any of the race categories.

Note: *Estimates are statistically unreliable. Data are for individuals age 18 and over. The California Health Interview Survey (CHIS) defines food hardship as not being able to afford enough food and only asks this question of adults with incomes less than 200 percent of the federal poverty level. CHIS data were downloaded from the online data portal, AskCHIS. Data for certain counties were automatically grouped according to CHIS data standards. Counties were grouped as follows: 1) Del Norte, Lassen, Modoc, Plumas, Sierra, Siskiyou, and Trinity; 2) Colusa, Glenn, and Tehama; and 3) Alpine, Amador, Calaveras, Inyo, Mariposa, Mono, and Tuolumne.
