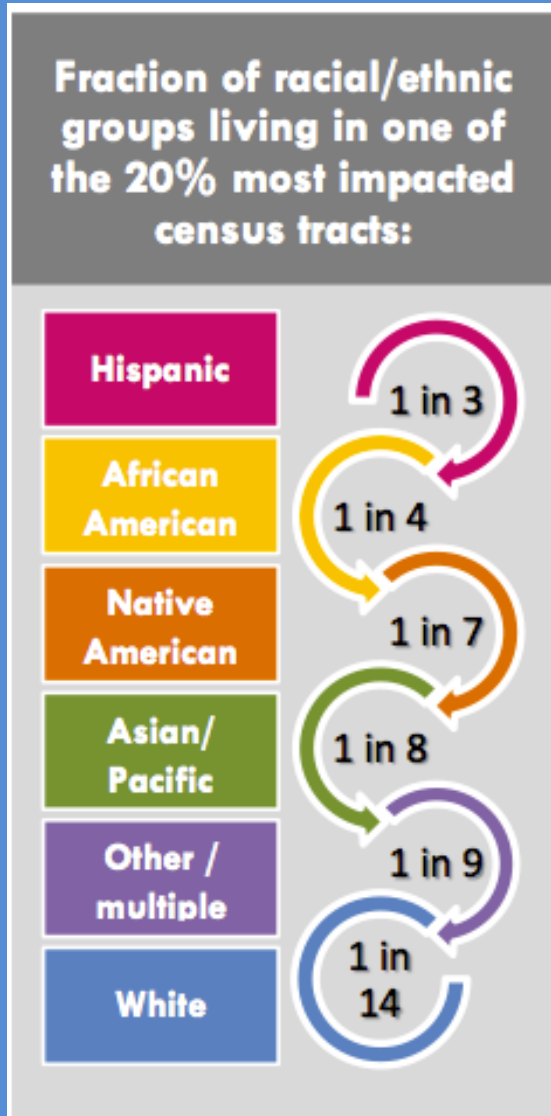

## Disproportionate Burden of Large Climate Polluters in Communities of Color



**California's cap & trade program covers some of the biggest polluting oil refineries across the state.**

**More than half are located in or within one-half mile of an environmental justice community.**

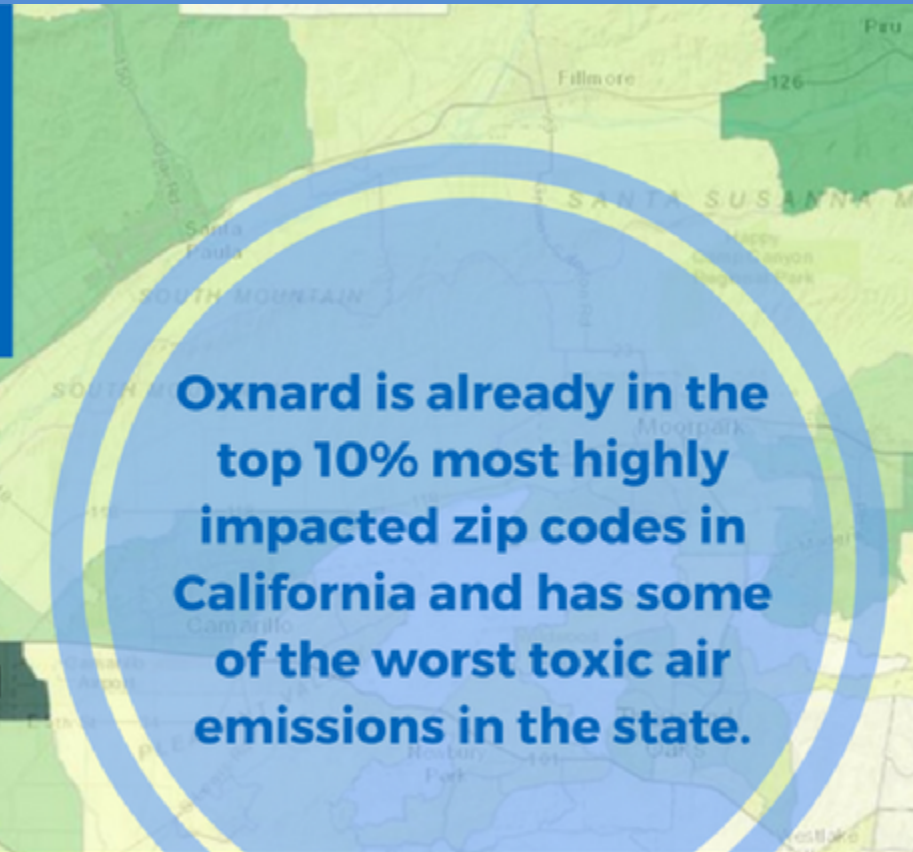

# Impacts and Investments of AB 693



**The Multifamily Affordable Housing Solar Roofs program will:**

**bring solar to thousands of renters while investing millions of dollars into environmental justice communities**

**lower energy bills for almost 210,000 low-income units**

**reduce greenhouse gas emissions by up to 3 million tons**

**dedicate funding of \$1 billion over 10 years, \$100 million per year**



**National City residents want safe and healthy neighborhoods.**

Auto body shops and other polluting industries can explode right next to homes, igniting dangerous fires and emitting toxic fumes.



Poor land use practices put the majority of polluting industries in the backyards of low-income neighborhoods.
