THE GOVERNOR'S PROPOSED BUDGET WOULD MAKE DEEP CUTS IN FUNDING FOR CALIFORNIA'S COUNTY OFFICES OF EDUCATION

California's public schools serve 6.3 million students in 1,043 school districts. The Governor's Proposed 2010-11 Budget proposes to reduce funding for K-12 education by \$2.7 billion — a reduction equivalent to \$432 per student. This analysis examines the local impact of the Governor's proposal to reduce apportionment funding for California's county offices of education (COEs) by \$58.6 million — a 14.2 percent reduction compared to 2008-09 funding. Apportionments provide general operating dollars for COEs, which support business, administrative, and curriculum services to school districts and financial oversight of school districts. In some counties with small populations, COEs provide administrative services that school districts perform in other counties.
